

Ariston Capital Customer Loyalty Contest Rules and Regulations

Ariston Capital Customer Rewards (“Account”) is issued by Ariston Capital LLC. (herein after “we”, “our”, or “us”) located in Media, PA. In these Program Rules, “you” or “your” means all persons and/or companies responsible for complying with this agreement, including the person who applied for the Financing and the person to whom we or our funding sources address billing statements, as well as any person who, and/or the company which, if applicable, agrees to be liable on the Account.

Ability to Earn and/or Redeem Rewards: If your Account is in default meaning you are late on any financing payment secured thru Ariston Capital or its funding sources or your Account is closed for any reason, and/or there is any fraud or abuse related to the accrual of points or rebates, as applicable, we reserve the right to prohibit you from earning or redeeming points/rebates through your Account until the next billing cycle after your Account is no longer in default, and to cause you to forfeit any points/rebates in your Account. If your points/rebates are forfeited for any reason, we will not reinstate these points/rebates to your Account. If your Account is closed for any reason, your membership in the Program will be terminated.

Membership: Your membership in the Program will be renewed automatically each year as long as your Account is open and not in default as defined above, or until we notify you of the Program’s cancellation. The Program is not subject to a yearly program fee.
